Update from the CASE Chair

Update from March 2011 CASE Meeting

The members' representatives to CASE met on March 3rd at IPEM Headquarters in York to discuss a wide range of issues on the Agenda.

The Annual Monitoring Performance Review (APMR) was almost complete at the time of the meeting. This was the first APMR to use the on-line reporting system which seemed to make the process much more refined both from an HEI perspective and from CASE perspective, although there is still some work required by the APMR group in assembling the data. Overall there was good student recruitment and retention and good student support is generally provided. In the present financial climate it does appear that there is limited progression from Postgraduate level to Masters level.

The Standard Operating Procedures (SOPs) were finally agreed and will be sent to all member organisations, although minor changes will be required following the meeting with IPEM in April to discuss financial arrangements.

The next Accreditor Training Day is to be held on May 20th at City University London. Attendance at these training days is mandatory for CASE Accreditors in order to ensure that there is uniformity when undertaking accreditation events on behalf of CASE. The programme for the day looks exciting so should have good attendance. The day is free to attend for the accreditors, but CASE is unable to offer expenses. If you feel you have the expertise to offer as a CASE Accreditor, please contact Cathy at IPEM and nominate yourself for this valuable role in promoting high quality sonographer education.
