### **CASE Working Party to research Ultrasound Courses & Programmes in the UK**

As previously announced in the last Newsletter, a Working Party has been formed to investigate the range and variety of ultrasound courses and programmes that are currently available in UK. The outcome from this work will inform any changes to the CASE remit as agreed by the Parent Bodies who have asked that they are kept informed of current progress on a regular basis. This group is now considering the issues and determining a strategy on how to proceed.

The Working Party met prior to Council on 16<sup>th</sup> October and it was agreed that the first assignment should be to undertake a scoping exercise to establish the range and variety of ultrasound courses and to include an investigation into the availability, level and accreditation (if any) currently available in the UK.

The Working Party will be carrying out a data collection with the co-operation of a wide range of individuals, including University Programme Leaders, Manufacturers, Professional Bodies, and other healthcare staff who organise courses. Staff and organisations will be targeted by email and letter with a request to provide as much relevant information related to their courses as possible.

The Working Party plans to complete this data collection by Christmas.
