## Report from the Chair

Ultrasound education is changing and a lot has happened since the last newsletter. CASE have welcomed The College of Podiatry as a member organisation and their input will be invaluable as more podiatrist incorporate ultrasound into their practice. Committee have streamlined the Annual Performance Monitoring Review (APMR) process to reduce the workload for programme leaders, while ensuring the APMR subgroup have the information they need to ensure quality education is being delivered by accredited programmes. Subgroups have been set up within the committee to ensure processes are efficient and that CASE can be proactive as education changes. There are now subgroups for:

- Strategy
- APMR
- Accreditation
- Third Trimester Growth Short courses
- Accreditor Education & Training
- Handbook

Each group is led by an experienced accreditor.

CASE can now accredit undergraduate education and are working with partners to ensure educational quality is maintained, whatever the delivery or educational level. Members of the Committee are playing a major role in development of the Apprenticeship Standard and are active members of the Integrated Imaging Workforce Working Group, set up by Health Education England, to develop the imaging workforce of the future.

Times are challenging but rest assured CASE is well positioned to ensure quality ultrasound education whatever the academic level or method of delivery.

## Annual Performance Monitoring Review

Report of APMR for Academic Year 2015-16

I am very pleased to report another successful APMR cycle.

Satisfactory returns were received from all 16 universities (there were 17 returns as Cumbria sent in 2 reports to include the new Direct Entry course). There are excellent, accredited programmes across the UK and it is encouraging to see an increasing number of students enrolled and obtaining awards as seen in the table below.

The range of modules and the backgrounds of the students is increasing, although there are still the difficulties of increasing workload and clinical pressures which has an effect on clinical placements for students.

As Simon mentioned in last year's report, there continues to be increased use of simulation and clinical skills labs in many courses which is satisfying to see.

These pathways could for example include undergraduate courses and degree apprenticeships.

## Independent Reporting Sonographers: could other countries follow the UK's lead?

Committee members Viv Gibbs and Gill Harrison along with colleague Hazel Edwards have recently had an article published in 'Imaging &Therapy and Practice' [available here to SOR members]. The article was written following presentations and debate at the European Congress of Radiology in Vienna, which showcased the educational and clinical practice in the UK.

The rapid growth in the use of ultrasound as a diagnostic imaging technology over the past forty years, has led to a demand for a workforce with the appropriate skills to perform and interpret the scans. For many years, the majority of ultrasound examinations in the United Kingdom, both obstetric and non-obstetric, have been performed by radiographers who have undergone postgraduate training. Sonographers' who have often undergone CASE accredited training are


able to scan, interpret and report their own examinations. Today, sonographer-led ultrasound services are essential and well established. The article discusses the difference between UK practice and that of many other countries in Europe and worldwide.

Traditionally, in the UK sonographers work closely alongside radiologists and it is this team-working, along with escalating demand, which has helped lead to the success of the current model. Rigorous professional guidelines and training programmes, often accredited by CASE, for sonographers in the UK have helped to ensure high standards of practice. Interpretation and reporting of ultrasound findings is a crucial part of ultrasound education and is fully integrated into the curriculum.

Looking to the future, it is anticipated that more sonographer-led ultrasound departments will start to emerge and independent reporting will eventually become common practice for sonographers beyond the UK. In order to support this however, it is important that appropriate, rigorous training programmes are established, and those who aspire to be independent reporting sonographers will need to forge good working relationships with medical colleagues.

## Charity Mission to The Gambia

Earlier this year, Committe representative for SVT, Anna Jerram, was was invited by Consultant Renal Transplant surgeon, Mr Afshin Tavakoli of Manchester Royal Infirmary, to accompany him and a team of two others on a trip to The Gambia. He had heard about the work of the Ida Bass Kidney Foundation (IBKF) charity through a colleague, and that the founder of the charity was looking for a surgeon who would be willing to perform Vascular Access surgery there.
